SECTION 4 FIRST AID MEASURERS

Eyes: Immediately flush eyes with water while lifting the upper and lower lids. Get medical attention if irritation persists.

SECTION 5 FIRE FIGHTING MEASURES

Extinguishing Media: Use water spray, carbon dioxide, alcohol foam or dry chemical to extinguish. Cool fire exposed containers with water.

Specific Hazards Arising from the Chemical: Residue will burn after the water has evaporated. Combustion products may include carbon oxides and acrylic monomers.

Special Protective Equipment and Precautions for Fire-fighters: Firefighters should wear full emergency equipment and NIOSH approved positive pressure self-contained breathing apparatus. Do not allow run-off from firefighting to enter drains or water courses.

SECTION 6 ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures: Wear appropriate protective clothing to avoid eye and skin contact.

Environmental precautions: Avoid release to the environment. Report releases as required by local, state and federal authorities.

Methods and Materials for Containment and Cleaning Up: Dike the spilled material. Attempt to reclaim the free product, if this is possible. Place in an appropriate container for use or disposal. Collect residue with inert material and place into a closable container for disposal. Wash spill area.
